Statement regarding the Toy Safety Directive 2009/48/EC (Safety of Toys)

In the retail sector, there is considerable uncertainty regarding the legal situation for products that do not bear a CE mark.

Following consultation with one of the relevant authorities, we hereby state:

Our juggling products are not toys within the meaning of the Directive, because:

- Since its establishment, HENRYS has not manufactured toys but produces top-quality juggling products for professionals and hobby jugglers alike.
- Our products are predominantly sold through specialist retailers and not through toy shops.
- Our advertising (catalogues, flyers) and packaging are aimed at an older target group.
- The quality, durability, design and price are in no case representative of a toy, but of premium-quality sports equipment.

Irrespective of this, we produce almost all of our products ourselves in Karlsruhe, Germany, and thus have complete control over materials, colours and production processes used and can consequently guarantee that all mandatory limits are observed (even those applicable to the safety of toys -> EN 71-3).

This statement is true for following items (HS code 9506 9190):

Juggling Balls Beanbags Premium, Superior and Stretch, Juggling Balls HiX; Diabolos Kolibri, Beach, Jazz, Vision, Circus and all belonging accessories like diabolo strings, diabolo handsticks and spare parts; Juggling Clubs Delphin, Loop, Classic, Pirouette, Albatros, Mirage and all belonging accessories like Knobs und Tops and other spare parts; Cigarboxes; Devilsticks Beat and Baracuda. Also our whole Fire Juggling Equipment Torches Nite Flite, Swinging Torches, Firedevilstick, Spitfire Stick, Fire Poi and Sparkling Club, and all belonging accessories and spare parts like Fire Wick.

Items we think they are concerning the Directive do have a CE-Sign and are tested according to the norm (Yo-Yos Lizard (A00020), Cobra (A00040), Tiger Snake (A00030) and Viper (A00011), Juggling Plates (J11020) and Juggling Plate Sets (J11030), Juggling Scarves (J10020, J10050) and Juggling Scarves Sets (J10030, J10050-VE).
